Membership

The District is governed by a Board of Trustees consisting of 5 members. Each member to represent of a different trustee zone unless a trustee was appointed at-large to fill a Board vacancy. The Board's powers and duties include the broad authority to adopt and enforce all necessary policies for the management and government of the public schools. Except as otherwise provided by law, trustees shall hold office for terms of four (4) years until July 1 of the year in which trustee's term expires.

All trustees shall participate on an equal basis with other members in all business transactions. Official action by Board members must occur at a duly called and legally conducted meeting. A meeting of the Board means convening to make a decision or to deliberate toward a decision on any matter.

School board members, as individuals, have no authority over school affairs or personnel, except as provided by law or as authorized by the Board.

The five (5) trustee zones for West Bonner County School District will be as follows:

Trustee Zone No. 1

BEGINNING at the intersection of the Idaho-Washington State line and Le Clerc Road (County Highway 9305) said point being on the West Bonner School District Boundary, thence leaving said School District Boundary Southeasterly along said Le Clerc Road (County Highway 9305) to its intersection with US Highway 2, thence East on said US Highway 2 approximately 0.70 miles to a the NE corner of the SW ¼, SW ¼ Section 19, Township 56 North, Range 5 West, BM, thence East approximately 2.25 miles to the NE corner of the SE1/4, SW1/4 of Section 21, Township 56 North, Range 5 West, BM, thence North 3.75 miles to the North ¼ corner of Section 4, Township 56 North, Range 5 West, BM, thence East 2.5 miles to the SE corner of Section 35, Township 57 North, Range 5 West, BM, thence North along the East line of said Section 35 to State Highway 57, thence Southeasterly along said State Highway 57 to its intersection with Saddler Creek, thence South on said Saddler Creek to its confluence with the Priest River, thence Easterly along said Priest River to the mouth of Sanborn Creek, thence Easterly along said Sanborn Creek to its intersection with Sanborn Creek Road, thence Southeasterly along said Sanborn Creek Road to its intersection with Eastside Road,

thence

Northeasterly along said Eastside Road to its intersection with Mirror Lake Road, thence
Northeasterly along said Mirror Lake Road to its intersection with an unnamed road
which follows along the north side of Crazy Creek, thence

Northwesterly along said unnamed road to the North line of Section 5, Township 56
North, Range 4 West, BM thence

East to the SE corner of Section 31, Township 57 North, Range 3 West, BM, being on
the East boundary line of the West Bonner School District, thence following said School
District boundary

North, then West then South to its intersection with said Le Clerc Road (County
Highway 9305) being the **POINT OF BEGINNING**.

Trustee Zone No. 2

BEGINNING at the intersection of the Idaho-Washington State line and Le Clerc Road
(County Highway 9305) said point being on the West Bonner School District Boundary,
thence leaving said School District Boundary

Southeasterly along said Le Clerc Road (County Highway 9305) to its intersection with
US Highway 2, thence

East on said US Highway 2 approximately 0.70 miles to a the NE corner of the SW ¼,
SW ¼ Section 19, Township 56 North, Range 5 West, BM, thence

East approximately 2.25 miles to the NE corner of the SE¼, SW¼ of Section 21,
Township 56 North, Range 5 West, BM, thence

North 3.75 miles to the North ¼ corner of Section 4, Township 56 North, Range 5 West,
BM, thence

East 2.5 miles to the SE corner of Section 35, Township 57 North, Range 5 West, BM,
thence

North along the East line of said Section 35 to State Highway 57, thence

Southeasterly along said State Highway 57 becoming Branch Road to its intersection
with US Highway 2, thence

East on said US Highway 2 (Albeni Road) to its intersection with Wisconsin Street,
thence

South on said Wisconsin Street and its Southerly extension to the thread of the Pend
Oreille River, thence

Southeasterly along said thread of the Pend Oreille River to its intersection with the
East line of Section 5, Township 55 North, Range 4 West, BM, thence

South to the SE corner of said Section 5, thence

West along the sections approximately 2 miles to the intersection with National Forest
Development Road 2550, thence

Meandering Westerly along said National Forest Development Road 2550 to its
intersection with Strong Creek, thence

Northwesterly along said Strong Creek approximately 0.75 miles to an unnamed road,
thence

Northeasterly along said unnamed road approximately 700 feet to its intersection with Loop Hoop Road, thence
Northwesterly along said Loop Hoop Road to its intersection with Old Priest River Road, thence
Westerly along said Old Priest River Road to its intersection with State Highway 41, thence
South on said State Highway 41 to its intersection with Rena Road, thence
Westerly on said Rena Road to the Idaho-Washington State line also being the Westerly boundary of the School District, thence
North along said State line and School District Boundary to the intersections with Le Clerc Road (County Highway 9305) , being the **POINT OF BEGINNING**.

Trustee Zone No. 3

BEGINNING at the Bonner-Kootenai County line on the Southerly boundary of the West Bonner School District, specifically being the Southeast corner of Section 36, Township 54 North, Range 5 West, BM, thence leaving said School District boundary North along Section lines approximately 1.5 miles to State Avenue, thence Northwesterly along said State Avenue to Ellie's Lane, thence North along said Ellie's Lane and continuing Northerly to the intersection of Blanchard Cutoff and National Forest Development Road 2550, thence East along said Blanchard Cutoff to Clagstone Road, thence Northeast along said Clagstone Road to the East line of Section 24, said Township and Range, thence North along section lines approximately 8.25 miles to the Northeast corner of Section 12, Township 55 North, Range 5 West, thence East approximately 2 miles to the SE corner of Section 5, Township 55 North, Range 4 West, BM, thence North along the East line of said Section 5 to its intersection with the thread of the Pend Oreille River, thence Easterly along said thread of the Pend Oreille River to its intersection with East line of Section 36, Township 56 North, Range 4 West, BM also the Eastern boundary of said School District, thence continuing along said School District boundary the remaining courses South to the Southeast corner of Section 36, Township 54 North, Range 4 West, BM, thence West approximately 4 miles to the Southwest corner of Section 33, said Township and Range, thence North along section lines approximately 1.63 miles, thence West approximately 0.25 mile, thence North approximately 650 feet, thence West approximately 0.5 mile, thence

North approximately 330 feet, thence
West approximately 0.25 mile, thence
North approximately 330 feet, thence
West approximately 0.5 mile, thence
South approximately 0.38 mile to the Center ¼ corner of Section 30, said Township and Range, thence
East approximately 0.5 mile to the East ¼ corner of said Section 30 and Spirit Lake Cutoff Road, thence
South then Southwesterly along said Spirit Lake Cutoff Road to said State Avenue, thence
Southerly along said State Avenue to a point approximately 150 feet Northwest of the intersection of said State Avenue and Walden Lane, thence
West from said point approximately 0.5 mile, thence
South approximately 650 feet to the South ¼ corner of Section 31, Township 54 North, Range 4 West, thence
West approximately 0.5 mile to said Southeast corner of Section 36, Township 54 North, Range 5 West, BM, being the **POINT OF BEGINNING**.

Trustee Zone No. 4

BEGINNING at the intersection of the East line of Section 36, Township 56 North, Range 4 West, BM, and the thread of the Pend Oreille River, being on the Easterly boundary of the West Bonner School District, thence
Westerly along said thread of the river to its intersection with the southerly extension of Wisconsin Street, thence
North on said extension and then Wisconsin Street to its intersection with US Highway 2 (Albeni Road), thence
West on said US Highway 2 (Albeni Road) to its intersection with State Highway 57 (Branch Road Street), thence
Northerly on said State Highway 57 to its intersection with Saddler Creek, thence
South on said Saddler Creek to its confluence with the Priest River, thence
Easterly along said Priest River to the mouth of Sanborn Creek, thence
Easterly along said Sanborn Creek to its intersections with Sanborn Creek Road, thence
Southeasterly along said Sanborn Creek Road to its intersection with Eastside Road, thence
Northeasterly along said Eastside Road to its intersection with Mirror Lake Road, thence
Northeasterly along said Mirror Lake Road to its intersection with an unnamed road which follows along the north side of Crazy Creek, thence
Northwesterly along said unnamed road to the North line of Section 5, Township 56 North, Range 4 West, BM thence
East to the East boundary line of the West Bonner School District, thence following said School District boundary the remaining courses

South approximately 2 miles to the SE corner of Section 7, Township 56 North, Range 3 West, thence
East approximately 1 mile to the intersection with the thread of the Pend Oreille River, thence
Southwesterly along said thread of the river to its intersection with the East line of Section 36, Township 56 North, Range 4 West, BM, being the **POINT OF BEGINNING**

Trustee Zone No. 5

BEGINNING at the Bonner-Kootenai County line on the Southerly boundary of the West Bonner School District, specifically being the Southeast corner of Section 36, Township 54 North, Range 5 West, BM, thence leaving said School District boundary North along Section lines approximately 1.5 miles to State Avenue, thence
Northwesterly along said State Avenue to Ellie’s Lane, thence
North along said Ellie’s Lane and continuing Northerly to the intersection of Blanchard Cutoff and National Forest Development Road 2550, thence
East along said Blanchard Cutoff to Clagstone Road, thence
Northeast along said Clagstone Road to the East line of Section 24, said Township and Range, thence
North along section lines approximately 8.25 miles to the Northeast corner of Section 12, Township 55 North, Range 5 West, thence
East approximately 250 feet to the intersection with said National Forest Development Road 2550, thence
Meandering Westerly along said National Forest Development Road 2550 to its intersection with Strong Creek, thence
Northwesterly along said Strong Creek approximately 0.75 miles to an unnamed road, thence
Northeasterly along said unnamed road approximately 700 feet to its intersection with Loop Hoop Road, thence
Northwesterly along said Loop Hoop Road to its intersection with Old Priest River Road, thence
Westerly along said Old Priest River Road to its intersection with State Highway 41, thence
South on said State Highway 41 to its intersection with Rena Road, thence
Westerly on said Rena Road to the Idaho-Washington State line also being the Westerly boundary of the School District, thence
South along said State line and School District boundary to the Southwest corner of Section 36, Township 54 North, Range 6 West, BM, thence continuing along said School District boundary
East along the Bonner-Kootenai County line said Southeast corner of Section 36, Township 54 North, Range 5 West, BM, being the **POINT OF BEGINNING**.
